## Article-I

### LEGAL FRAMEWORKS OF BOTH THE ORGANIZATIONS

Purash Kanpur Haridas Nandi Mahavidyalaya, established in 1966, a State Government-aided and affiliated college of the University of Calcutta, having its campus at Village & Post Office- Kanpur, Howrah, PIN- 711410, West Bengal, India, represented by its Teacher-in-Charge, hereinafter referred to as the **FIRST PARTY** (which term or expression shall, unless excluded by or repugnant to the context, be deemed to mean and include its successor in office, representatives, administrators, and assignees) is included under Section 2(f) & 12(B) of the UGC Act, 1956, and has rapidly emerged as one of the most promising educational institutions in Howrah District, West Bengal with a strong focus on the dissemination of knowledge, offering Undergraduate Honours and General Courses in the B.A., B.Sc. and B.Com streams, and dedicated for all-round empowerment of the rural youth.

Ramakrishna Mission Vidyamandira, an esteemed autonomous residential degree college affiliated to the University of Calcutta, located at Post Office - Belur Math, Howrah, West Bengal, India, PIN - 711202, offering U.G. and P.G. courses in various subjects, founded in 1941, under the auspices of Ramakrishna Mission, inspired by Swami Vivekananda's motto 'Education is the manifestation of perfection already in man.' and 'Atmano Mokshartham Jagaddhitaya Cha', represented by its Principal, hereinafter referred to as the **SECOND PARTY** (which term or expression shall, unless excluded by or repugnant to the context, be deemed to mean and include its successor in office, representatives, administrators, and assignees) is recognized by the UGC under Section 2(f) and 12(b), and has steadily evolved into one of the leading academic institutions dedicated to the betterment of the society and service to the mankind.

- j. Any other academic activity that is mutually agreed upon and is beneficial to both the parties

### Article-IV

#### FINANCIAL MANAGEMENT

Involvement of funds, if required under this Memorandum of Understanding, will be subjected to approval of relevant authority/authorities.

### Article-V

#### LOCATION OF ACTIVITIES

The Parties agree to implement the programmes stated in Article-III at **PURASH KANPUR HARIDAS NANDI MAHAVIDYALAYA**, situated at Kanpur, Howrah and **RAMAKRISHNA MISSION VIDYAMANDIRA**, Situated at Belur Math, Howrah.

Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

## **Article-VI**

### **MODE OF CONDUCTING THE PROGRAMMES**

The programmes will be conducted in online, offline and blended (offline and online) mode as and when necessary.

## **Article-VII**

### **CONFIDENTIALITY AND INTELLECTUAL PROPERTY RIGHTS (IPR) PROTECTION**

Both the institutions shall respect and retain confidentially in each/any of the collaborative efforts, and all collaborative academic exercises shall be guided, directed and impelled by the greater academic interest of both the colleges, and not any other/commercial interest.

This MOU will respect Intellectual Property Rights and any intellectual matter developed by the collaborative efforts of the two institutions shall be retained by them.

## **Article-VIII**

### **DURATION AND TERMINATION**

1. It is understood that this agreement will come into effect from the date of being signed by both parties and will be established for a period of five(5) years.
2. After these five(5) years, it will be mutually extended for the same period, unless one of the parties expresses an intention (by written notification) to cancel the agreement at least 90 days before the expiry date.
3. Either Party may terminate this MOU at any time by giving written notice to the other Party on its intention to terminate this MOU, at least six (6) months prior to the date of the termination
4. The termination of this MOU shall not affect the completion of any project/s and programme/s in progress and not completed at the time of termination.

## **Article-IX**

### **AMENDMENT**

1. This MOU may be amended or revised at any time by mutual written consent of the Parties and such amendment shall form an integral part of this MOU.
2. Such amendment/s or revisions shall come into force on the date as may be determined by the Parties.
3. The amendment of this MoU will not affect the terms of activities ongoing at the time of notification of amendment unless otherwise agreed upon between the parties.
4. Any additions, changes, or deletions to this document must be approved by the representatives of both parties.
5. All notices shall be in writing and shall be directed to these representatives.
6. The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both parties, will be attached as annexes to this agreement.
7. The specific sub-agreements between both Parties will specify their objectives, conditions and ways of execution, financial support, the period the sub-agreement will be in effect, and administrative responsibility within each institution.

## **Article-X**

### **NON-EXCLUSIVITY**

This Agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third parties.

## **Article-XI**

### **SPECIAL PROVISIONS**

1. Each party will take approval from the other party in writing prior to using the later's name and logo for the activities hereunder on a case-by-case basis.
